2040 RTP Update

- Mr. Swiatek provided an overview of this agenda item.
- Handouts: WILMAPCO 2040 Regional Transportation Plan Update Schedule; WILMAPCO's FY 2016 19 TIP and 2040 RTP Air Quality Conformity: Detailed Timeline

- Mr. Swiatek reviewed the draft timelines for both the 2040 RTP update, generally, and the air quality conformity analysis, specifically. Council adoption of the RTP it is expected in January 2015, following technical and public feedback which will commence shortly.
- Air quality conformity analyses for both counties are required given that this is a full RTP update, and the update will include some new projects not previously modeled. WILMAPCO is still working with both DOTs on the project lists. The AQS will be asked to review projects which are flagged for potential inclusion in the model next month. The full conformity schedule is below.
