Meeting Notes

- The AQS accepted the notes from the July 17 and August 14 meetings.

Proposed FY 2015 CMAQ Spending

- Mr. Swiatek provided an overview of this agenda item.
- Handouts: September 3 e-mail from Drew Boyce (DelDOT) to Tigist Zegeye (WILMAPCO) regarding Delaware's proposed CMAQ spending; Proposed CMAQ spending in Delaware packet, including: July 10, 2014 letter to Tigist Zegeye (WILMAPCO) from Bill Geronimo (DelDOT) regarding proposed STP, FTA Urbanized Area, CMAQ, 5310, and Transportation Enhancement Program funding; FY 2013, 2014, 2015 and 2016 Spend Plan for Nonmotorized Projects; ITMS FY 2015 Obligation Plan; 2015 Scope of Services: Rideshare Program
- Mr. Swiatek provided an overview of developments since the last AQS meeting. DelDOT has accepted that ITMS had ineligible CMAQ activities: "ITMS Planning and Engineering," "ITMS TMC Systems," and "ITMS field device support – civil air patrol". Funding for these programs will be switched from CMAQ to STP.

- DelDOT also acknowledged that "Project Management" under the Rideshare Program is ineligible for CMAQ, and CMAQ dollars will not be applied to that portion.
- Ms. Gray was concerned that updated funding amounts were not provided to reflect this, and that specific projects within the programs to be funded by CMAQ are still not being detailed. Ms. Zegeye said that it does not matter which specific projects they are, since the program they fall under is eligible. Ms. Gray replied that without specific details, quantification of the emissions benefits was impossible. Mr. Dixon said that Mr. Donaldson (DelDOT) will begin working towards showing the emissions benefits for the ITMS projects.
- The group reviewed a separate series of handouts, which included much of the CMAQ material presented at the previous AQS meeting, along with a detailed scope of the 2015 Rideshare Program. Ms. Gray was troubled that the Federal Fiscal Year 2015 Obligation Plan for ITMS spreadsheet was not updated to reflect the removal of the three projects from CMAQ consideration. Mr. Dixon noted that his understanding is that only a portion of the funding for "ITMS Planning and Engineering," and the "ITMS TMC Systems," would be removed there are some CMAQ eligible elements within those projects.
- There was a lengthy discussion about the need in future to quantify the emissions benefits of projects being considered for CMAQ spending. Mr. Simons felt that this could be done through Baker's AQONE Model. Ms. Zegeye said that WILMAPCO has considered purchasing the software, but has hesitated due to software transitions, costs relative to benefits, and questions about who will run the program. Ms. Dunigan also said that the model's assumptions are at the county level which does not reflect nuanced development patterns across New Castle County. The group was in agreement, however, that utilizing the AQONE model was still in Delaware's best interests.

2040 RTP/FY 2016 TIP Conformity Analysis

- Mr. Swiatek provided an overview of this agenda item.
- Handouts: Detailed Air Quality Conformity Timeline (9/4/14); New Castle County emissions results July 2014 and September 2014.
- Mr. Swiatek said that the scenario analyses for the RTP have delayed the conformity results for New Castle County, forcing a revision of the conformity timeline. The new timeline is presented on the following page.

- Mr. DuRoss reviewed updated conformity results for New Castle County, which showed a drop in all emissions and all years tested. These figures should not be considered final, however, until additional quality checks are completed. Mr. DuRoss estimated that this should be done by early October.
- The group was comfortable with the revised conformity timeline, along with the updated conformity analyses for New Castle County.

Air Quality Technical Prioritization

- Mr. Swiatek provided an overview of this agenda item.

- Mr. Swiatek said air quality technical scores are needed for several projects associated with the 2040 RTP. He then reviewed the scoring methodology of the air-quality portion of the project prioritization process. The group scrutinized, but ultimately accepted all of the draft scores, with one revision. A final listing is provided on the following page.

- Mr. Simons asked if Delaware have any bad air quality days this past summer. Ms. Gray replied that she believed there were three ozone exceedances.
