Is this being considered?

Our homes have already been appraised and most homeowners have signed contracts. We were told in January that the project had to be put on hold because of this Churchmans Study and that we would know more in the fall. We had assumed that this study would be finalized by now, not just beginning. Will a decision on whether the Apex project can move forward need to wait an additional year?
