WHEREAS, WILMAPCO must demonstrate transportation conformity on its Transportation Improvement Programs and Regional Transportation Plans in accordance with federal requirements; and

WHEREAS, the New Castle County and Cecil County Air Quality Conformity Determinations for the 2050 Regional Transportation Plan: 2023 Update and Amended FY 2023-26 Transportation Improvement Program have undergone appropriate technical review as required by the interagency conformity consultation process; and

WHEREAS, the emission projections outlined in the 2050 Regional Transportation Plan: 2023 Update and Amended FY 2023-26 Transportation Improvement Program show conformity to all appropriate budgets; and

WHEREAS, the 2050 Regional Transportation Plan: 2023 Update and Amended FY 2023-26 Transportation Improvement Program underwent a 30-day public review and comment period, including one public workshop;

NOW, THEREFORE, BE IT RESOLVED that the Wilmington Area Planning Council approves the New Castle County and Cecil County Air Quality Conformity Determinations for the 2050 Regional Transportation Plan: 2023 Update and Amended FY 2023-26 Transportation Improvement Program.
