The Route 9 Monitoring Committee (R9MC) is pleased to strongly support the Delaware Department of Transportation's (DelDOT) request for Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant funding for the Route 9 Corridor.

The *Route 9 Transportation and Land Use Master Plan* was a collaborative effort between government, civic leaders, and other key stakeholders.
