WILMAPCO's 2022 CMAQ Performance Plan Update

- Mr. Swiatek reviewed this agenda item. (1:10 into the Zoom recording)
- Mr. Swiatek began by discussing the project schedule. He noted the final emissions reduction targets have been received for Maryland. He thanked MDOT for those and the

coordination MDOT provided with BMC. BMC sent the congestion related targets for the Aberdeen region required in the 2nd Period Baseline Report. We are waiting on the 2- and 4-year targets for Delaware. Given the delay, this month's TAC meeting could be held jointly with the AQS where a final draft document (with all data) could be acted upon.

- Ms. McGuire and Mr. Tardy reviewed draft Delaware targets. They are nearly complete, but work is still needed to finalize them. Ms. Zegeye asked when they would be finalized. Mr. DuRoss replied within a week or so. The AQS had no substantive questions or comments.

RTP 2050: 2023 Update – Conformity Determination

- Mr. Swiatek reviewed this agenda item. (12:48 into the Zoom recording)
- Mr. Swiatek began by reviewing the timeline for the air quality conformity determination. The finalized project list was, originally, going to be set at this meeting. However, there have been delays in building the project list as many new projects have been added. So, for this meeting, we will review where the project list stands. We hope to finalize the list at the joint TAC/AQS meeting on August 18.
- In Cecil County, much has remained unchanged. WILMAPCO has flagged seven projects from the Highway Needs Inventory to take a closer look at, just to see if they are capacity additions and within the timeframe of the RTP. Ms. Burke said MDOT would review these again, but as reconstructions, will likely not add capacity. Ms. Zegeye offered to have an offline meeting if needed ahead of August 18 between WILMAPCO and MDOT.
- On the Delaware side, an offline meeting will be needed next week between WILMAPCO and DelDOT. While several projects have been flagged, we need to determine the model year to use. Mr. DuRoss agreed with the call for the middle of next week.
- Mr. Galvin noted that the SR 1 Widening, US 301 to Puncheon Run (excluding Odessa to Smyrna Section) includes part of Kent County. A follow up will be needed to see how WILMAPCO and D/KC MPO should handle modeling this project. Ms. Dunigan suggested changing the project limits in the WILMAPCO RTP.
- Ms. Burke asked for access to the project Master List that is being reviewed. Ms. Dunigan will send that to her.
- Mr. Pinckney asked about the WILMAPCO Project Prioritization Process. Mr. Swiatek provided an overview of the multifaceted process, with more information available here, that he shared in the chat: <u>http://www.wilmapco.org/prioritization/</u>. Mr. Pinckney asked how project delivery and other goals fit in. Ms. Dunigan replied that the Council does have the ability to move project rankings around based on factors external to the technical process, but this rarely happens.
