

Employment: 1990 to 2004

Employment Trends for Cecil County Residents Reflect those of New Castle County Residents

New Castle County has historically had a healthy economy when compared to the United States as a whole. Figure 1 shows New Castle having unemployment rates around 1 to 2 percent lower than the U.S. average. By 1990, the base of the New Castle County economy, the chemical industry, had given way to the banking and credit industry. This transition allowed New Castle County to maintain its economic health throughout the 1990s and into the early 2000s.

Cecil County, on the other hand, had unemployment rates higher than the national average until recently. Despite a strong economy nationally in the 1990s, Cecil County still had an unemployment rate higher than the national average. However, by 2000, the unemployment rate dipped below the national average of 4% to 3.5% as shown in Figure 1. Cecil County's unemployment rate has remained below the national average, in spite of a national economic slowdown from 2000 to 2003. The best glimpse into this are the commuting patterns in the WILMAPCO Region of Cecil and New Castle County, which show a substantial number of Cecil County residents traveling outside the County for work.

In fact, the majority of employed persons in Cecil County commute outside its boundaries to work, and the majority of these commuters travel to neighboring New Castle County. Between 1990 and 2000, the total number of Cecil County residents who worked outside the County grew by almost a third. By 2000, 33.4% of Cecil County residents traveled to New Castle County to work, and another 22.7% traveled to counties outside the WILMAPCO Region. In contrast, 85.6% of New Castle County residents stayed within its boundaries when traveling to work. The increase in the number of Cecil County commuters who travel to New Castle County shows how the economies of the two counties have grown more integrated. - New Castle County's Labor Force increased 26,540 or 11.01%.
- Cecil County's Labor Force increased 11,479 or 31.91%.
- New Castle County had its largest labor force in 2001 at 274,039 persons, and Cecil County in 2003 at 47,564.
- Cecil County and New Castle County had the highest number of unemployed persons in 1991 with 4,415 and 14,350, respectively. Also in 1991, both counties saw their largest unemployment rates in 1991 with 6% and 12%, respectively.
- New Castle County had its lowest number of unemployed in 1999 with 7,852, and its lowest unemployment rate during that same year at 3.0%.
- Cecil County had its lowest number of unemployed in 2000 with 1,609, and its lowest unemployment rate during that same year at 3.2%.
- Cecil County's unemployment rate dipped below New Castle County's for the first time in 2004 during the fifteen year period examined. Cecil County's rate stood at 4.3% and New Castle County's at 4.4%.



How Cecil and New Castle County Residents Make their Living as of 2000

In the 2000 decennial U.S. Census, certain households were asked to list the occupations of people in them. Since only a select number of households were asked this, widely-used statistical techniques filled in the gaps for those households not surveyed about their occupations. These techniques constructed statistics on how the residents make their living for entire political divisions, be it the United States as a whole, or its constituent states, counties and municipalities.

- For both counties, the majority of residents worked in a job in either the Management, Professional, and Related Occupations category, or the Sales and Office category. Together, these two "white-collar" categories comprise 54.5% of Cecil County residents who go to work, and 67.5% of New Castle County as of 2000.
- Service occupations employ a little more than 13% of New Castle and Cecil County residents.
- Farming, Fishing, and Forestry jobs employ fewer than 1% of the residents for both counties.
- The Construction, Extraction, and Maintenance category and the Production, Transportation, and Material Moving category employed more residents of Cecil County than New Castle County. As of 2000, these two "blue-collar" categories employed 31.5% of Cecil County residents and 18.8% of New Castle County residents.

- In 2004, the Finance and Insurance sector had the most employees on their payrolls in New Castle County. The number of employees increased 17.2% from 2001 to 2004. However, because of expected layoffs, the Finance and Insurance sector is expected to drop from its top spot.
- Retail Trade had the second most employees in New Castle County in 2004. In 2001 and 2002, the Retail Trade sector held the top spot, before being overtaken by Finance and Insurance in 2003. However, between 2001 an 2004, Retail Trade saw a 2.8% drop in the number of employees on its payrolls.
- The prominence of the Retail Trade sector in New Castle County reflects the employment picture at the national level. According to the Bureau of Labor Statistics, the Retail Trade sector employed the most people in the United States in 2003 and 2004, and the second most in 2001 and 2002.
- The Health Care Social Assistance sector employed the second highest number of people from 2001 through 2004 in New Castle County. Hospitals/healthcare systems are major employers throughout the WILMAPCO Region (see pages 10 and 11).
- Employment levels in the Transportation and Warehousing sector decreased nationally from 2001 through 2003, before an increase in 2004. In 2003, New Castle County Transportation and Warehousing establishments employed 10.4% fewer people than in 2001. Between 2003 and 2004, however, the number of employees increased by 6.3% in New Castle County, and 1.6% nationally. The United States as a whole saw this same trend of a decrease and subsequent increase between 2001 and 2004.
- The number of employees in the Management of Companies and Enterprises sector decreased 36.9% between 2001 and 2004. This sector lost 7,176 employees during this period, even though the number of business establishments increased during this period (see page 5).

For the first quarter of 2005, New Castle County ranks 24th highest nationally in wages


According to the Bureau of Labor Statistics in a November 1, 2005 press release:

The average weekly wage in New Castle County, Delaware was \$1,005 in the first quarter of 2005, 4.9% higher than one year earlier...Regional Commissioner Sheila Watkins noted that New Castle County ranked 24th highest in wage level and 20th in rate of wage growth among the 322 largest counties (those with 75,00 or more jobs) in the United States. Average weekly wages in New Castle County were \$230 higher than the national average in the first quarter of 2005.

- From 2001 to 2004, New Castle County workers in the Utilities sector had higher average annual wages than the national average for Utilities. In 2004, the average annual wage of Utilities workers in New Castle County was \$10,013 higher than the national average. This difference in 2004 is smaller than in 2001, when Utilities workers earned \$17,471 more than the national average.
- The average wage for New Castle County workers in the Finance sector rose above the national average in 2003. Between 2001 and 2004, wages rose 10.1% for the United States as a whole in the Finance sector, whereas New Castle County saw a higher growth rate of 38.1%
- The average wage for New Castle County workers in the Management of Companies and Enterprises sector fell below the national average in 2003. Average annual wages in New Castle County for this sector decreased every year from 2001 to 2004, while rising every year during this period for the United State as a whole. Nationwide, average annual wages increased 16.1% for this sector, while they decreased 19.4% in New Castle County.

- From 2001 through 2004, the Management of Companies and Enterprises sector had the most number business establishments in New Castle County. Retail Trade was the sector with the largest number of business establishments for the entire U.S. during this same period.
- A disproportionately large number of U.S. business establishments in the Management of Companies and Enterprises sector were located in New Castle County. In 2001, 9.0% of all U.S. business establishments in the Management of Companies and Enterprises sector or 3,356 were located in the New Castle County. By 2004, New Castle County had 3,491 out of 40,799 U.S. business establishments in this sector. This is 8.6% of the U.S. total for Management of Companies and Enterprises
- Between 2001 and 2004, New Castle County business establishments in the Wholesale Trade sector; Professional, Scientific, and Technical Services sector; and Health Care Social Assistance sector had increases in their numbers of 32.7%, 26.8%, and 11.9%, respectively.
- While the number of people employed in Manufacturing sector deceased significantly between 2001 and 2004, the number of business establishments stayed roughly the same.

- From 2001 to 2004, Manufacturing businesses had the most number of employees in Cecil County. Manufacturing saw an increase between 2002 and 2004 of 12.2%, while Manufacturing in the United States as a whole decreased. Manufacturing payrolls decreased in New Castle County as well.
- Retail Trade in Cecil County had the second most employees on its payrolls from 2001 to 2004. The sector did see a drop between 2002 and 2003, but rebounded in 2004 to surpass the number of employees it had in 2001.
- Transportation and Warehousing payrolls in Cecil County plummeted between 2001 and 2004, decreasing 37.7%.
 While New Castle County saw about a 6.3% increase between 2003 and 2004, Cecil County establishments only
 added one new employee, essentially holding steady. While number of employees on Transportation and Warehousing payrolls declined in Cecil County, the number of business establishments increased from 2001 to 2004 (see
 page 8).
- The number of employees working in Cecil County for the Health Care Social Assistance sector saw a steady increase of 12.9% from 2001 to 2004, compared to New Castle County which saw a 7.9% increase. The U.S. as a whole saw an 8.0% increase during the same period.
- The U.S. as a whole added employees each year from 2001 to 2004 in the Accommodation and Food Service sector. Cecil County lost employees between 2003 and 2004 in this category, after increases between 2001 and 2003. New Castle County saw a decrease between 2001 and 2002 before adding 937 new employees by 2004. Nevertheless, by 2004, Cecil county had 248 more employees in the Accommodation and Food sector than in 2001.
- While small in number (only 268 in 2004), private sector Educational Services saw a sizable 78.7% increase in number of employees between 2001 and 2004.
- Finance and Insurance saw a 21.6% increase in the number of employees on its payrolls from 2001 to 2004.

CECIL COUNTY: Average Annual Wages in the Private Sector



- Manufacturing's average annual wage in Cecil County increased 9.4% between 2001 and 2004, lower than the 11.3% national rate for this time period. However, the average annual wage for workers was consistently above the national average from 2001 to 2004. The average annual wage was \$5,398 higher than the national average for 2001; \$6,595 for 2002; \$6,759 for 2003; and, \$5,059 for 2004.
- Whereas workers in New Castle County's Finance and Insurance sector earn more than the national average, Cecil County's workers earn about half. Cecil County workers in the Finance and Insurance sector earned 48.3% of the national average in 2001, 53.0% in 2002, 50.2% in 2003, and 48.4% in 2004.
- While incomplete, the data for the Professional, Scientific, and Technical Services sector suggest that many of the highest paid positions in Cecil County are in this sector. In 2003, the average annual salary for workers in this sector was \$54,421. Of all the data that hasn't been suppressed (see note on the Management of Companies and Enterprises sector at top of page) the 2003 Map 2: Cecil County, MD and its planning districts figure for this sector is the highest one for the period between 2001 and 2004.

- Retail Trade had the most business establishments in Cecil County each year from 2001 to 2004. The number of establishments increased 12.1% in this period.
- The Construction sector had the second most business establishments in Cecil County, and the number of business establishments in this sector increased 5.8% from 2001 to 2004.
- Unlike the U.S. as whole and New Castle County, Transportation and Warehousing never saw a decrease in its total number of business establishments from 2001 to 2004. Business establishments were added each year from 2001 to 2004, with the number increasing 24.1%. Interestingly, while the number of business establishments in this sector increased, payrolls decreased 37.7% between 2001 to 2004.
- The number of business establishments in the Health Care-Social Assistance sector increased 30.1% from 2001 to 2004.
- The Educational Services sector added 4 new business establishments between 2001 and 2004, but 78.7% more employees.

Agriculture in Cecil County:

Despite a shrinking land base because of suburbanization, agriculture still has a large presence in Cecil County, indicative of an area on the metropolitan fringe.

The Cecil County Office of Economic Development reports that about 37.7% of the County's land or 84,000 acres is farmland, and much of this land is devoted to cash grain and dairy farms.

The principal crops grown in the county are corn, soybeans, and wheat. According to the United States Department of Agriculture, Cecil County farmers produced 2,836,100 bushel of corn for grain; 650,600 bushel of soybeans; and, 322,900 bushel of wheat in 2005, with a yield of 145.4, 37.4, and 70.2 bushel, respectively. Substantial amounts of barley and alfalfa are also grown.

While dairy cows are the major livestock raised in Cecil County, farmers also raise sheep, chicken, beef cattle, and horses. In the case of horses, Cecil County has farms that raise standardbreds and thoroughbreds.

Also, Cecil County has a number of organic farms catering to markets in nearby urban areas and beyond.

NEW CASTLE COUNTY: Major Employers

The top employers in New Castle County reflect a mix of organizations. They serve as regional draws and employ a large number of people with advanced educations. As of 2005, the companies employing the largest number of people are in the credit and banking industry. Chemical and auto manufacturing companies have a significant presence, even after years of declining payrolls. Higher education, healthcare, information technology, business services, and government fill out many spots in this list. Please note: These figures do not include workers who are independent contractors.

CECIL COUNTY: Major Employers

Four of the top six employers in Cecil County are in manufacturing i.e. factories/assembly plants. However, the other two are service sector employers, as well as the majority in the 100 to 249 employee range. These major service sector employers represent a wide variety of businesses. The dominance and mix of service sector employers reflects Cecil County's suburban nature. (The data does not get more detailed than ranges because Maryland state law forbids the release of the exact number of employees for specific non-governmental employers.)
