Action Item #12: To Endorse the City of New Castle Transportation Plan Update

Description/Summary of Item:

Staff will present the draft City of New Castle Transportation Plan. Plan updates the 2009 Plan and builds upon the City's 2020 Comp Plan. Planning was led by WILMAPCO, City of New Castle, and DelDOT with an advisory committee and four public workshops. Preferred concepts were selected based on community feedback and technical analysis, and address speed management and traffic calming, capacity enhancements, intersection improvements, bicycle/pedestrian connections, parking, stormwater management, and gateways.

The PAC did not take action on this item. Recommendations and public outreach were presented to the PAC on June 13, 2022.
